WHAT KIND OF INFORMATION DO WE COLLECT?

We collect: full name, e-mail address, name of the organisation/company & country.

FOR WHAT PURPOSES DO WE COLLECT THE DATA FOR?

The data we request from you when you register to STYLE project webinar (29.4.2020) online is the data we require in order to organise and report the webinar in question. The data is used for two purposes. Only information that is strictly necessary for these purposes is collected.

Firstly, the information is used to provide you with the information regarding the webinar you register for and will be participating in, both before and after the event.

Secondly, the data concerning your organisation/company and country may also be used in contexts where the webinar is reported. Examples of this kind of use are e.g. research article, in which the contents of the webinar are presented. When reporting the webinar, the data will be used in a manner, where individuals or organisations cannot be identified.

SHARING INFORMATION

Next to the STYLE research team at Finland Futures Research Centre at the University of Turku, the following three persons have access to the collected information for the organisational purposes: Dr. Anu Tuominen (VTT Technical Research Centre of Finland Ltd), Dr. Marko Tainio (Finnish Environment Institute) and Dr. Riikka Paloniemi (Finnish Environmental Institute).

We do not transfer personal information collected to organizations or companies for marketing purposes. We will not transfer personal data to countries outside the EU/EEA.

RETENTION OF INFORMATION

The personal information you have provided to us is processed and stored for the aforementioned purposes as long as the purposes are valid and after this for a limited time due to our purposely determined back-up and deletion routines.

SECURITY

The FFRC and the University of Turku are dedicated to protecting your personal information. We have adopted internal security policies and instructed our employees accordingly in order to comply with applicable legislation on Personal Data Protection. We have implemented appropriate procedures and security measures to protect your personal information.

The data will be stored on a server managed by the University of Turku. It cannot be accessed by people outside of the STYLE research group of the Finland Futures Research Centre, University of Turku.

YOUR RIGHTS AS A DATA SUBJECT

- You have the right to request access to and rectification or erasure of your personal data.
- You also have the right to object to the processing of your personal data and have the processing of your personal data restricted.
- You have an unconditional right to object to the processing of your personal data for direct marketing purposes.
- If processing of your personal information is based on your consent, you have the right to withdraw your consent at any time. Your withdrawal will not affect the lawfulness of the processing carried out before you withdrew your consent.
- You may always lodge a complaint with a data protection supervisory authority
